## Connersville Woman Found Stabbed To Death

Largen, searched the shopping center Thursday evening for Mrs. Remley when she failed to return to the elder Largen's house nearby.

Paul Largen was to have driven her and Mr. and Mrs. Carlos Largen back to the young Largen's house, Carlos Largen said.

Carlos Largen said Mrs. Remley was not known to stay out late at night and normally was around home. He also said she was rather lonely because her husband was away in Korea. They had been married since July 6, 1968.

**WHEN SHE** disappeared Mrs. Remley was wearing a brown, long-sleeved blouse and tan denim jeans and moccasins.

She was about 5 feet, 2 inches tall, weighing about 135 pounds and had long, reddish-blond hair.

Police said last night they have no clues as to her murderer.

Meanwhile, two more suspects in the slaying of young Bayles were given polygraph tests yesterday and were cleared of involvement in the case police said.

**A TOTAL** of 14 persons have been given polygraph tests in the three weeks since the murder, but no arrests have been made.

The nude body of the 10-year-old Bayles boy was found Oct. 3 five miles north of Knightstown, stabbed once in the back and several times in the lower abdomen. His bicycle was found near his Westside home along with news-

papers he was delivering for the Indianapolis Star.

State Police Capt. Robert K. Gray said yesterday that one of his department's top investigators, Lt. Wayne Hall of Seymour, has been brought into the investigation to "take a fresh look at the information in the case."

**GRAY SAID HALL**, who is in charge of investigations at the Seymour post, met yesterday with Indianapolis Police detective Sgts. Robert J. Tirmenstein and James M. Strode to review the case.

The two detectives also met later in the day with other State Police investigators assigned to the case to review all information gathered last week.

Tirmenstein said two men, whose names keep coming up in connection with the killing, will be checked thoroughly today.

**CAPT. RAYMOND A. KOERS**, newly appointed head of the Indianapolis Police Department homicide and robbery section, said yesterday new procedures have been established to insure that superior officers will be on duty weekends to take charge of murder investigations.

In any murder case where an arrest is not made at the scene or any other case of a controversial nature, notification will be made to Koers and one of his two assistants, who will go directly to the scene of the crime.

Koers said either he or Lts. Leonard F. Dehn or Joseph G. McAtee will be on 24-hour call on weekends.

**THE CHANGE** in procedure was prompted by slow action in beginning the Bayles murder investigation.

Meanwhile, contribution of \$2 yesterday in \$1 gifts raised to \$6,070.61 the total reward fund for information leading to the conviction of the slayer.
